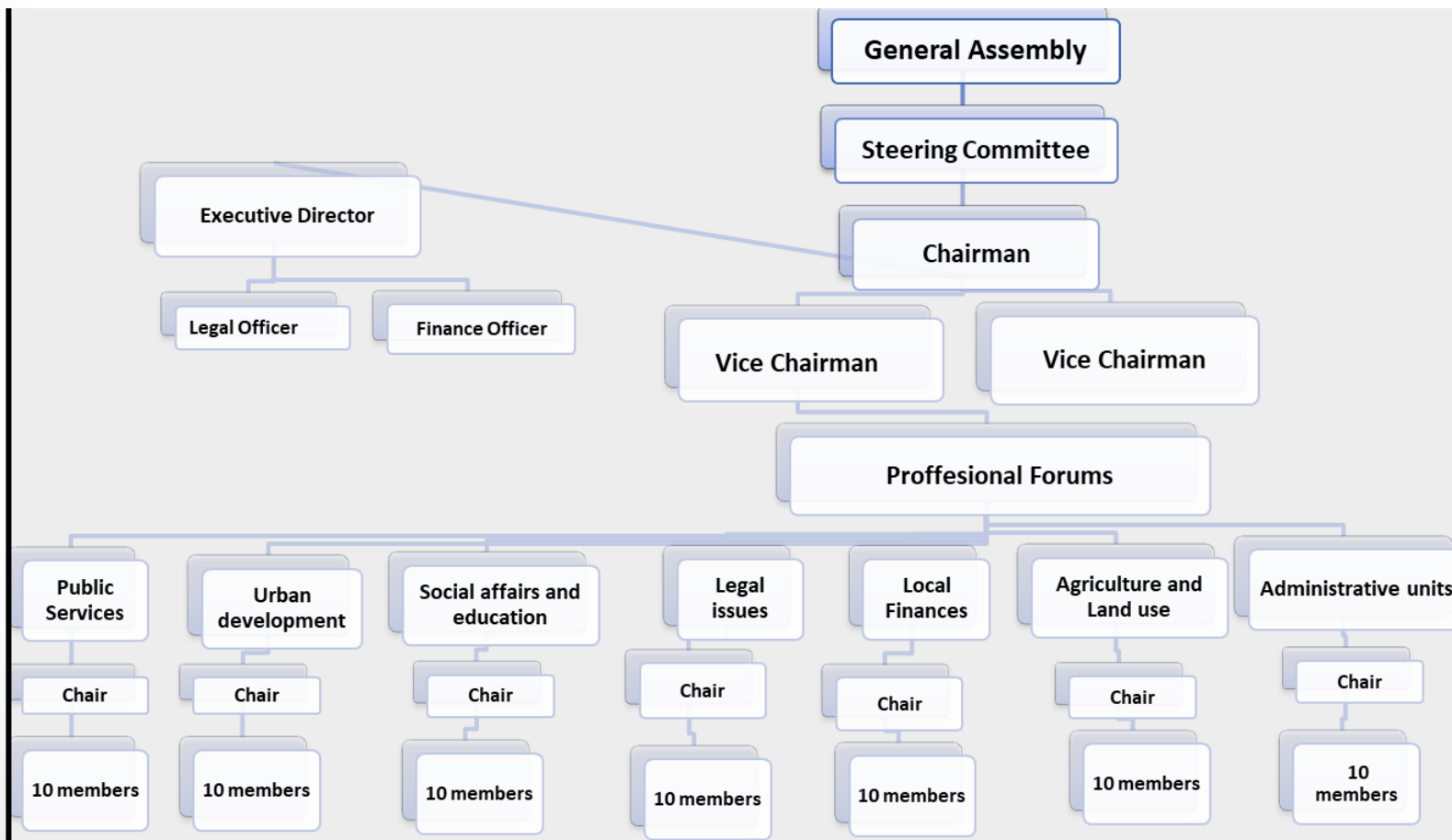


Short presentation

- AAM is established in 1993 upon the initiative of 10 Mayors as the first LGA in Albania.
- Establishment of AAM is based on Law on Local Government and it is registered as an NGO with a private body status.
- AAM' operational structure is made of elected bodies and executive staff.
- Our aim is the consolidation of AAM as an independent organization in representing the interests of local government and the consolidation of new municipalities coming from the Territorial Reform (61 new municipalities).
- Our involvement in territorial reform and other decentralization reforms enabled AAM to acquaint a vast experience and knowledge in local government and to be recognized by LGUs as an important support actor in training provision, lobbying, communication platform and establishing partnerships.

The main focus of work

- **Empowerment of AAM** as a stakeholder in decentralization. AAM is intended to serve as an educational and advocacy institution for Mayors and local elected officials, civil servants involved in the decentralization and EU-integration debate in Albania.
- **Knowledge enhancement** for Municipalities. The aim is to improve the delivery of newly-appointed tasks and responsibilities following major legal developments.
- **Transparency and accountability** enhancement addresses transparent and participatory municipal management as a tool to increase accountability of local politicians to their constituency.
- **Organizational development** to help improve municipal management, in addition to contributing to the discussion on the transfer of competencies to local government and the process of fiscal decentralization in Albania.

Challenges

- Internal challenges relate to limited human resources due to the own financial capacities coming from low membership fees. This is addressed with the establishment of Professional Forums.
- Establishment of “parallel” structure by central government that overlap with activity of AAM such as Agency for Support of Local Government.
- Poor coordination from donors with AAM in implementation of interventions affecting local government, with AAM having more of a symbolic role rather than an active player.
- Strengthening, Consolidation and unification of voice of local governments
